# WESTMARC 2025 LEGISLATIVE AGENDA

## Intent & Purpose:

**This legislative agenda is intended to guide conversation and position statements of WESTMARC during the 2025 Legislative Session. If proposed legislation requires further clarity in terms of establishing an official position or providing for action, it will be brought forward for consideration through the existing operating policies and procedures. All position statements or actions regarding proposed legislation will be communicated to WESTMARC's members.**

## Economic Development

- WESTMARC supports efforts to enhance the range of economic development funding mechanisms available in Arizona.
- WESTMARC supports governments' ability to review, evaluate and sunset economic development incentives.
- WESTMARC supports the protection of existing Economic Development tools such as the foreign trade zone and opportunity zone benefits that attract business to Arizona.
- WESTMARC supports efforts to grow and expand a diverse, inclusive, skilled, and knowledgeable workforce.
- WESTMARC supports responsible workforce housing solutions that are affordable and sustainable.

## Education

- WESTMARC supports high expectations for all Arizona students via rigorous academic standards, an aligned assessment system and a fair, equitable and meaningful accountability system to measure academic progress.
- WESTMARC supports a referendum to permanently remove the Aggregate Expenditure Limit (AEL) for pre K-12 education, and the annual override of the AEL until such time as the voters approve the referendum.
- WESTMARC supports the extension of Proposition 123 for an additional 10 years to increase funding for K-12 schools.
- WESTMARC supports a uniform system of reporting on public education spending of all education resource delivery systems (elected governance, appointed governance, ESAs and STOs for taxpayer transparency.)
- WESTMARC supports nationally competitive funding and sustainable, long-term investment in education spanning early childhood through K-12, including through public-private partnerships. We support resources for educator compensation, recruitment and retention; high-quality preschool programs; accessible childcare services; parent education initiatives; all-day kindergarten; and comprehensive K-12 operational support.
- WESTMARC supports increased funding to strengthen and expand out-of-school-time (OST) programs across Arizona, ensuring K-12 youth have safe, enriching spaces to learn, grow, and thrive outside of school hours.
- WESTMARC supports workforce market competitive funding for Career and Technical Education Districts (West-MEC) and Career Technical Education programs and excellent workforce participation.
- WESTMARC supports competitive funding and fiscal management for the Maricopa County Community College District.
- WESTMARC supports the post-secondary education systems to ensure access for qualified students, world-class research capabilities, and excellent workforce preparation. We support the Arizona Board of Regents and Arizona's post-secondary institutions as they endeavor to grow the state's health care workforce, while accelerating leadership in bioscience, life science, and research. We support an enterprise model of operations and maintaining leading edge research infrastructure.
- WESTMARC supports reducing the amount of unfunded mandates to be tasked to our pre K-12 schools and any initiatives or efforts that advance the Arizona Education Progress Meter goals that culminate with Achieve 60AZ (the statewide attainment goal of 60% by the year 2030).

## Fiscal Responsibility/Taxation

- WESTMARC supports clear, understandable, and practicable tax and fiscal policies that will retain and grow existing business, attract new capital investments, and promote job growth in Arizona.
- WESTMARC supports the preservation of state shared revenues at current levels and opposes any reduction or cap.
- WESTMARC opposes rollovers and sweeps of dedicated funds as a mechanism for balancing the budget.
- WESTMARC supports continuous improvement of Department of Revenue policies and procedures to ensure tax collection accuracy, management and system ease of use by taxpayer.
- WESTMARC supports finding a revenue offset for cities' losses as a result of residential rental tax preemption.

## Healthcare

- WESTMARC supports appropriate reimbursement of healthcare providers.
- WESTMARC supports continuing and improving access to healthcare and use of telehealth and other consumer friendly options.
- WESTMARC supports efforts to grow a diverse, efficient, and effective healthcare system.
- WESTMARC supports available treatment and support for behavioral health and substance abuse issues.
- WESTMARC supports healthcare workforce policies that address the unprecedented health care worker shortages across the healthcare industry and build a high-quality health professions pipeline that seeks to meet the demands of Arizona communities for years to come. We support solutions that leverage Arizona's existing healthcare workforce in areas of training, retention and recruitment opportunities to mitigate statewide healthcare workforce shortages.

## Infrastructure

- Recognizing that infrastructure is essential to enable job creation and economic development, WESTMARC supports ongoing efforts to develop new short and long term funding as well as expand and increase existing funding (i.e. gas tax) to meet Arizona's infrastructure needs.
- WESTMARC supports multimodal transportation options for the West Valley.
- WESTMARC supports the planning and development of an efficient transportation system in the West Valley.
- WESTMARC supports the planning and construction efforts of I-11.
- WESTMARC recognizes that water is a finite resource and thus supports responsible water management practices and conservation efforts, including preservation of the 1980 Groundwater Management Act.
- WESTMARC supports appropriate action to ensure Arizona has an adequate supply of gasoline, broadband, electricity, natural gas, water and other critical resources.
- WESTMARC supports the protection of critical energy infrastructure, including generation, transmission, and distribution assets.
- WESTMARC supports the implementation and funding for the Drought Contingency Plan (DCP). We support the ongoing negotiation regarding future Colorado River operating rules (Reconsultation) and the pursuit of larger contributions from other Colorado River Basin States to conserve additional Colorado River water and ensure Arizona does not continue to carry a disproportionate burden of reductions for the benefit of others.
- WESTMARC supports the distribution of federally appropriated funds to projects that provide durable, long-term water savings on the Colorado River.
- WESTMARC supports responsible, strategic development & implementation of AI technologies that support workforce, business and economic development within legal and safety best practices.

## Legal and Regulatory Affairs

- WESTMARC supports a pro-business environment that does not place undue burden on business.
- WESTMARC supports local governments as partners in economic development.
